The October 22, 2020, Annual/Regular Meeting of the Suffolk County Economic Development Corporation ("SCEDC") was held, electronically, via Zoom conference call, pursuant to Executive Order No. 202.11 - Continuing Temporary Suspension and Modification of Laws Relating to the Disaster Emergency - by Governor Andrew M. Cuomo of the State of New York.

Natalie Wright, Chair of the SCEDC, called the meeting to order at 12:30 pm, and asked Lisa Broughton, Deputy Executive Director/CFO of the SCEDC, to do a roll call.

I. PUBLIC COMMENT

II. <u>NEW BUSINESS</u>

A. St. Johnland Assisted Living, Inc. - Preliminary Inducement

Jonathan Keyes informed the board that we received this application from St. Johnland Assisted Living, Inc. It's a 100 bed unit facility located in Kings Park, right off Sunken Meadow.

Melissa Bennett, this project is to finance an assisted living facility with the proposed issuance of bonds with the amount not to exceed 44 million dollars. Mostly consisting of tax exempt bonds with a small portion of taxable bonds. It would finance the construction and equipment of the 100 bed facility, as well as some required reserve funds.

Timothy Shea and Mary Jean Weber spoke about the St. Johnland Assisted Living, Inc. Project. Attached you will find their PowerPoint presentation.

Upon motion made by Kevin Harvey, and seconded by Anthony Giordano, it was:

RESOLVED, Approve St. Johnland Preliminary Inducement.

RESOLVED, to approve the Suffolk County Economic Development Corporation budget for 2021.

Unanimously carried 6/0.

B. <u>Auditing Services</u>

Ms. Broughton noted that staff was unable to issue a new solicitation for services this year as intended due to COVID-related constraints, but reported that last year the SCEDC worked with Sheehan & Company and had had a very good experience, and that, consistent with the Corporation's professional service procurement policies, it was the Audit & Finance Committee's recommendation to continue with Sheehan & Company for 2021.

After further discussion and;

Upon a motion by Kevin Harvey, seconded by Anthony Giordano, it was:

RESOLVED, to continue with Sheehan & Company to provide auditing services to the Suffolk County Economic Development Corporation in 2021.

Unanimously carried 6/0.

C. Accounting Services

Ms. Broughton reported that likewise staff was unable to issue a new solicitation for services this year as intended due to COVID-related constraints, but at the same Audit & Finance Committee on October 22, 2020, the Committee discussed accounting services provided by Albrecht, Viggiano, Zureck & Company, P.C. ("AVZ"), and it was recommended that the SCEDC continue with AVZ for 2021.

Upon a motion by Anthony Giordano, seconded by Kevin Harvey, it was:

RESOLVED, to continue with Albrecht, Viggiano, Zureck & Company, P.C. ("AVZ") to provide accounting services to the Suffolk County Economic Development Corporation in 2021.

Unanimously carried 6/0.
