The December 17, 2020 Annual/Regular Meeting of the Suffolk County Economic Development Corporation ("SCEDC") was held, electronically, via Zoom conference call, pursuant to Executive Order No. 202.11 - Continuing Temporary Suspension and Modification of Laws Relating to the Disaster Emergency - by Governor Andrew M. Cuomo of the State of New York.

Natalie Wright, Chair of the SCEDC, called the meeting to order at 11:30 am, and asked Lisa Broughton, Deputy Executive Director/CFO of the SCEDC, to do a roll call.

#### I. PUBLIC COMMENT

Chairwoman Wright turned over to Audit and Finance Committee Chair Kevin Harvey for consecutive meeting of Audit and Finance Committee

Committee Chair Harvey called the Audit and Finance Committee to Order – Lisa Broughton took roll call of Committee:

Having a quorum, the committee is asked to consider the proposed issuance of bonds for the St. Johnland project, which was discussed at the October meeting.

Melissa Bennet gave a brief overview on this project.

2. Agape Community Sports Services Kings Park LLC – Final Inducement.

Jonathan Keyes spoke about the project; this is the final inducement the preliminary inducement was passed back in February. A public hearing was held on Tuesday, December 15, 2020 no comments were received, we received many letters of support from the community.

Brief discussion about town permits, Long Island based general contractors, and the timeline for the project.
