Lee Dennison Building, 100 Veterans Memorial Highway, Hauppauge, NY, and was called to order by Sarah Lansdale, Chair of the SCEDC, at 12:30pm

#### III. OLD BUSINESS

# A. Loan Agreement Amendments

Andrew Komaromi addressed the board on the two amendments SCO and IGHL. Change of the transaction documents to reflect the interest rate setting on the variable rate bonds from LIBOR to SOFR. With IGHL they have two additional requests. First request five new affiliates of IGHL be added as guarantors under the Bonds. The new affiliates to be added as guarantors are East End Disability Associates, Inc. ("EEDA"), Head Injury Association, Inc. ("HIA"), Maryhaven Center of Hope, Inc. ("Maryhaven"), Riverhead Hostel Holding Corp. ("RHH") and Kinexion, Inc. ("Kinexion"). Second request, in order to organize and share management and infrastructure services among all of the IGHL affiliates, Kinexion, Inc., a New York not-for-profit corporation was formed to serve as a management services organization for the IGHL affiliates. Kinexion will provide essential management and infrastructure services and supports on

#### **1. SCO**

#### 3. St. Johnland

Carolyn Trespasz addressed the board, modification to the loan agreement by and between the SCEDC and St. Johnland Assisted Living, Inc. relating to the originally issued \$35,655,000 Suffolk County Economic Development Corporation Revenue Bonds, Series 2021 in order to add an additional covenant for the benefit of the bondholders. The bond documents executed in connection with the Bonds required us to provide certain annual reports to the trustee and bondholders, which we were not able to provide for the past year because the project was not yet complete. We have requested that the Trustee and bondholders waive this default and, because the EDC is also a party to the documents, as you may recall, in November 2022 the SCEDC approved the waiver of the default at our request. We have continued to discuss the proposed waiver of default with bondholders since November 2022 and we expect to receive the necessary bondholder consents shortly on the condition, in part, that we amend the loan agreement to require us to hold regular investor calls.

Upon a motion by Cris Damianos, and seconded by Kevin Harvey, it was:

RESOLVED, to appr the amendment for St.Johnland.
